Instructions

The Standing Order (SO) for use of Post-Secondary Education Account (PSEA) is a onetime application and the SO instructions will apply to all future withdrawals from PSEA until the SO is terminated or replaced, regardless of which approved institution you attend.

This online form is for PSEA holder who wishes to use his/her own PSEA for approved fees and charges conducted by the institution. The form is to be completed by either:

i. the account holder (the student), if he/she is 21 years old or above; ORii. a parent / legal guardian if the account holder (the student) is below 21 years old.

5) Click on the box to authorise PSE Scheme Administrator to make deduction from your / your child's / your ward's PSEA to repay for the loan(s).
