

NIEC Data Sharing Consent Form (for new PET students)

Note: If you are under 18 years of age, your parent or legal guardian must agree and acknowledge to have read and understood NIEC's Privacy Statement (<https://niec.edu.sg/privacy-policy>) and this Data Sharing Consent Form.

1. From 1 January 2019, all Pre-Employment Training (PET) Early Childhood (EC) Courses offered by the Institute of Technical Education (ITE), Ngee Ann Polytechnic (NP), and Temasek Polytechnic (TP), will be jointly conducted by one of the aforementioned institutions, and the National Institute of Early Childhood Development (NIEC). The qualification will be awarded by NIEC in collaboration with either ITE, NP or TP.
2. Unless otherwise stated, the terms used in this NIEC Data Sharing Consent Form shall have the same meaning as set out in the NIEC's Privacy Statement (as defined below).

Collection of Personal Data

3. I understand and acknowledge that the Personal Data that I provide to NIEC shall be treated as confidential, treated in compliance with the Personal Data Protection Act 2012 (PDPA) or any other applicable laws and treated in compliance with the NIEC's Privacy Statement (as defined below). Such data may include personal particulars, contact details, academic records, medical information which is treated as personal data under the PDPA (Personal Data).
4. I agree and consent to NIEC collecting my Personal Data to provide services, such as enrollment, and administration of the courses (hereinafter referred to as Services in this form).

Marketing Communications

Withdrawal of Consent

8. I understand that I may request to withdraw consent to the collection, use, disclosure, storage and processing of your Personal Data at any time. I understand that as the use of personal data may be essential to providing me with the Services, NIEC may not be able to continue to provide such Services to me, should I withdraw consent.
