NEW EDUCATION AND TRAINING RESOURCES FOR YOUTH WORKERS TO HELP YOUTHS NAVIGATE A COMPLEX WORLD

Youth Work Day 2022 - Celebrating Youth Work and Beyond

At Youth Work Day 2022 today, four new partnerships were announced to provide education and training to youth work professionals, including an onboarding course for youth workers, introduction of legal resources for those who work with youths, a youth work-focussed academy and the development of youth work-related training courses.

- YWD 2022 was organised by the Youth Work Association (Singapore) (YWAS) and Ngee Ann Polytechnic (NP), with support from the Ministry of Social and Family Development (MSF). Organised annually, YWD celebrates the contributions of youth work professionals as well as initiatives to build the sector's capabilities to better serve our youths. Held at NP this year, in conjunction with the 10th anniversary of YWAS, the event was originally mooted by the Social Service SkillsFuture Tripartite Taskforce (STT) Youth Work Sub-Team.
- 3 Mr Eric Chua (Senior Parliamentary Secretary for Social and Family Development and Community, Culture and Youth) was the guest-of-honour at YWD 2022. Mr Chua was joined by 300 guests comprising youth work professionals from social service agencies, schools, community groups, social work students, and partners.

Youth Work Sector - Initiatives and Partnerships to Build Capabilities

- To ensure that our youth workers are well-equipped to support our youths and their families, MSF continues to leverage partnerships with academia, professional associations and social service agencies to build the sector's competencies. MSF, in partnership with NP, will be launching a Youth Work Onboarding Course that will introduce foundational training for new entrants to the sector, based on feedback from youth workers. The course is slated for implementation in early 2023.
- In its continued effort to promote professional development in the youth work sector, YWAS has partnered the Singapore Association of Women Lawyers (SAWL) and Allen & Gledhill (A&G). This collaboration will jointly aim to provide advancement

and protection for youths and their families with legal knowledge and insights through workshops, legal clinics, and online question-and-answer sessions.

- NP also announced a new Youth Development Academy (YOuDA) which will provide training, conduct research on youth development and youth mental wellness and promote collaborative partnerships within the sector. YWAS will partner NP in developing courses offered at the Academy.
- The event also included masterclasses on pertinent areas of youth work, which were conducted by experienced practitioners from partnering agencies to educate participants on how to provide holistic support to youths. The synopses of the masterclasses, as well as more information on the new initiatives announced, can be found in **Appendix A**.
- 8 Mr Chua said in his Guest-Of-Honour address, "Youths play an important part in Singapore's future. Under the Forward Singapore exercise, we are committed to refresh our social compact and work together with our community partners like the youth work sector and our youths to build a Singapore that leaves no one behind."
- 9 Mr Nicholas Gabriel Lim, President of YWAS added, "We are glad to have the support of our partners Singapore Association of Women Lawyers and Allen & Gledhill to provide legal expertise and resources for youth workers and our youths. It is encouraging to see everyone come together to augment one another's efforts, skills, talents and resources for the overall well-being of our youths, and in turn, their families, communities and our society."
- Mr Lim Kok Kiang, Principal & CEO of NP said: "We are excited to be a catalyst for positive youth development through our Youth Development Academy (YOuDA). As Youth Work Association (Singapore)'s official training partner, we look forward to jointly shape the future of youth work by empowering sector professionals and ensuring they remain adaptive to address emerging needs of youths."

ABOUT SOCIAL SERVICE SKILLSFUTURE TRIPARTITE TASKFORCE (STT)

The Social Service SkillsFuture Tripartite Taskforce (STT) was formed in April 2019 to:

- i. Drive, coordinate and implement tripartite collaborations for manpower development initiatives in the social service sector; and
- ii. Provide advice, expertise and input in curriculum, training pathways and professional practice to enhance capabilities and effectiveness of manpower in the social service sector.

The STT comprises representatives from Social Service Agencies (SSAs), professional associations, academia and the Government. In its first term, the STT played an important role in providing feedback to MSF and the National Council of Social Service (NCSS) to support the social service sector in coping with manpower challenges arising from the pandemic. The STT initiated new entry pathways, such as the Learning Support Educator specialist track in the early intervention sector, and partnered with National University of Singapore (NUS) and Singapore University of Social Sciences (SUSS) to support the demand for psychologists. Currently in its second term, the STT will further enhance our efforts on manpower and talent development to increase the capabilities of our SSAs.

ABOUT YOUTH WORK ASSOCIATION SINGAPORE

The Youth Work Association Singapore (YWAS) was started by a band of veteran youth work practitioners who felt the need to distinguish youth work as a distinctive practice, in the late 2000s. YWAS was formally registered as a society with the Registry of Societies in March 2012.
